"SHALL THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 38, EL PASO COUNTY, COLORADO, BE AUTHORIZED TO CONTRACT A BONDED INDEBTEDNESS, TO BE ISSUED IN ONE OR MORE SERIES, IN A PRINCIPAL AMOUNT NOT EXCEEDING \$6,300,000, TO BEAR INTEREST AT A NET EFFECTIVE INTEREST RATE NOT EXCEEDING 12.00% PER ANNUM, AND EACH SUCH SERIES OF BONDS TO MATURE SERIALY WITHIN 25 YEARS OF THEIR DATE, FOR THE PURPOSES OF ACQUIRING AND IMPROVING SCHOOL GROUNDS; ENLARGING, IMPROVING, RENOVATING, REPAIRING, AND MAKING ADDITIONS TO SCHOOL BUILDINGS; CONSTRUCTING AND ERECTING SCHOOL BUILDINGS; AND EQUIPPING AND FURNISHING ANY SCHOOL BUILDINGS, SUCH BONDS TO INCLUDE COVENANTS, AGREEMENTS AND DETAILS REQUIRED OR PERMITTED BY LAW AS MAY LATER BE DETERMINED BY THE BOARD?"
