**SCHOOL BOND ELECTION
JOINT DISTRICT NO. 23 JT OF THE COUNTIES OF
EL PASO AND ELBERT
(PEYTON 23 JT SCHOOL DISTRICT)
EL PASO AND ELBERT COUNTIES, COLORADO
FEBRUARY 2, 1988**

Shall Joint District 23 of the counties of El Paso and Elbert be authorized to contract a bond indebtedness, to be issued in one or more series, in an aggregate principal amount not exceeding two million three hundred thousand dollars (\$2,300,000), to bear interest at a net effective interest rate not exceeding twelve percent (12%) per annum, and each series of bonds to mature serially within twenty (20) years of their dates; for the purposes of:

1. erecting, constructing and equipping an elementary school building,
2. renovating the district's existing school building and related improvements,
3. renovating, erecting, constructing and equipping an addition to the district's existing gymnasium and related improvements,
4. erecting, constructing, and equipping an addition to the district's existing school building - specifically, an administrative area, media center, and corridor on the south side of the existing gymnasium,
5. making additions and improvements to new or renovated school facilities, and
6. related instructional improvements;

such bonds to include covenants, agreements, and details required or permitted by law as may later be determined by the Board of Education of the District.
